To be divided 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally among all other starters. Weights: 122 lbs. Non-winners of \$60,000 twice at a mile or over since November 16, 2018 allowed 3 lbs.; \$50,000 once at a mile or over since October 16, 2018, allowed 5 lbs.; \$40,000 at a mile or over in 2018-2019 allowed 7 lbs.
