FILLIES, THREE YEARS OLD No nomination fee. \$1,000 to pass the entry box and \$1,500 additional to start. Supplementary nominations may be made by the closing time of entries at a fee of \$3,000 which qualifies to start with \$200,000 Guaranteed of which 60% to the Owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. WEIGHTS: 122 lbs. Non-winners of \$50,000 at a mile or over in 2019, allowed 3 lbs.; \$40,000 at a mile or over any time, allowed 5 lbs. (Maiden and Claiming races not considered in allowances). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings, excluding money won in restricted races (See reverse side for additional starting limitation information). Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Certain finishing positions in this race will earn points to qualify for the 2019 Kentucky Oaks, pursuant to the official rules for the Road to the Kentucky Derby published by Churchill Downs Incorporated.
