FOR COLTS AND GELDINGS, THREE-YEAR-OLDS AND UPWARD, WHICH WERE BRED IN ARKANSAS AND QUALIFY UNDER THE RULES GOVERNING SAME By subscription of \$300, which shall have been paid to the A.T.B.H.A. by December 31, 2016. \$500 to enter and \$1,000 to start. \$100,000 Guaranteed (of which A.T.B.H.A. would furnish \$50,000) to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. Weight: 123 lbs. for 4-year-olds and up, 118 lbs. for 3-year olds. Non-winners of \$25,000 in 2019 allowed 3 lbs.; \$20,000 in 2019 allowed 5 lbs.; \$15,000 in 2018 or 2019 allowed 8 lbs. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. There is no split provision. If the number entering exceeds the starting gate capacity, the number to start will be determined under RULE 2258 of the Arkansas State Racing Commission's Rule of Racing, by the Stewards and by horses that have accumulated the highest earnings. No Owner can start more than one horse to the exclusion of a single entry. Supplementary nominations may be made by the closing time of entries at a fee of \$2,500.
