In the event that the race oversubscribes a list of reserve candidates will be established and horsemen will be informed of their horses position on that reserve list. Horses that have been invited into the body of the race will be asked for confirmation of planned participation by 12:00 PM (CST) on Friday, April 26, 2019. In the event Oaklawn does not receive confirmation by this deadline then the invitation will be revoked and a horse on the reserve list will be invited into the body of the field. Oaklawn will continue this process until closing time of entries. \$300,000 Guaranteed with 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to be divided equally between remaining starters. WEIGHTS: Colt and Geldings 123 lbs.; Fillies 118 lbs. Starters to be named through the entry box by the usual time of closing. The Winning Horse will automatically be given an entrance into The Preakness. The Horse must be nominated to the Triple Crown to be eligible. The Owner of the winner will receive a trophy.
