THREE YEARS OLD WHICH WERE BRED IN ARKANSAS AND QUALIFY UNDER THE RULES GOVERNING SAME By subscription of \$300 each, which shall have been paid to the A.T.B.H.A. by December, 31, 2017. \$500 to enter and \$1,000 to start. \$100,000 Guaranteed (of which A.T.B.H.A. would furnish \$50,000) which will be reduced so as to allow 1% to be paid to the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. WEIGHT: 122 lbs. Non-winners of \$25,000 allowed 3 lbs.; \$18,000 allowed 5 lbs.; \$15,000 allowed 7 lbs. Starters to be named through the entry box at time of closing. The Owner of the winner to receive a trophy. THERE IS NO SPLIT PROVISION. If the number entering exceeds the starting gate capacity, the number to start will be determined under RULE 2258 of the Arkansas State Racing Commission's Rules of Racing, by the Stewards and by horses that have accumulated the highest earnings. No Owner can start more than one horse to the exclusion of a single entry. Supplementary nominations may be made by the closing time of entries at a fee of \$2,500.
