Early Bird closing Thursday, February 7, 2019 at \$750 for The Southwest, The Rebel and The Arkansas Derby. Certain finishing positions in this race will earn points to qualify for the 2019 Kentucky Derby, pursuant to the official rules for the Road to the Kentucky Derby published by Churchill Downs Incorporated.
